

## THE WRITING ASSIGNMENT – SPRING 2016

Each of you will be assigned one of the following five cases:

International Shoe v. State of Washington; please focus only on the issue of minimum contacts

Heart of Atlanta; please focus only on the issue of whether the statute is constitutional under the Commerce Clause

Krasner v. HSN Nordbank; please focus only on the standing issue

Hustler Magazine V. Falwell; please focus on only the issue of the intentional infliction of emotional distress claim;

MGM Studios v. Grokster, please focus on the basis the appeals court decides that Grokster has liability to MGM; and

Yale Diagnostics v. Estate of Harun; please focus only on the issue of the basis for awarding compensation – is it based on quasi-contract, or is there an actual contract between the doctors and the recipient of their services
